What is Crime? The formal definition of a crime is an act that contravenes the original criminal law. However, if we consider the broader social processes that give it meaning, it is apparent that, there is much more to defining crime, than simply referring to the text of a statute. If criminals are characterized as black, poor, or young, then a significant proposition of the class that struggles with the failures of the economic system can be repressed by the Criminal Justice System. Also, by constructing a picture of who is most likely to be a criminal, those who use the rhetoric create stereotypes which they can use in their fear-mongering, scape-goating by the Criminal Justice System can also feed anti-immigration attitudes and policies and deflects people's attention from the failure they are experiencing in the system. Included in this presentation is a discussion "age-crime curve". This curve, which for individuals typically peaks in the late teen years, highlights the tendency for crime committed during an offender's younger years and to decline as age advances
